- Prof. Rahul Buchade informed all members that Alard College of Pharmacy got Facilitation Center (FC), in the month of June 2018 for admission of B. Pharm

and Direct Second Year B. Pharm for A.Y 2018-19 and the admission process is underway for both B. Pharm and M. Pharm.

- Principal further informed all members that Alard College of Pharmacy has received EOA by AICTE for A. Y. 2018-19 on 10th April 2018. The affiliation letter by SPPU is being followed up and will be received shortly.
- Prof. Swati Patil informed that the recruitment process of faculty for the year 2018-19 has been initiated; the advertisement for the same was published on 28th March 2018. One new faculty has joined the College and remaining vacancies need to be filled.
- Prof. Swati Patil also informed that two Faculty development Programs for teaching and non- teaching staff will be organized in the month of July 2018 and three more will be planned for 2018-19.
- Principal Dr. Sonia Singh further discussed about the NAAC accreditation, she
 mentioned that Pharmacy is now been considered under Health Sciences and its
 updated manual will be displayed on NAAC website shortly. Till then we will
 continue to collect documents required for NAAC. She discussed status of
 Strategic Plan for Short term and Long term goals of college.
- Ms. Sheetal Patil pointed out that updating the Academic file; increasing number
 of value added courses, increase in Placement drives, etc. need to be
 implemented for improvement of college activities.
- Dr. Arshia discussed about implementation of Rain Water Harvesting & Energy Saving Devices in College. She mentioned that Alard College of Engineering has prepared the proposal for Solar Plant at Alard Campus and the procedure of approval is in process.
- Dr Arshia also informed that new MOUs have been signed by Aspire Academy for Placement Training, THIRDIP Intellectual Property for awareness of IPR, Future Media Advertising and Media Service, Bangalore for Designing of printed material.
